

ABOUT THE PARK SYSTEM

The Doylestown Township Park System was created in 1971 with the acquisition of the 13 acre Sauerman Park. In the years that followed, additional park land was acquired including Turk Parks I, II and III, Bridgepoint Park, Neamand Park and the Ridings Tract. Central Park was opened to the public in 1995. To date, the township maintains over 700 acres of park land and facilities - providing both active and passive recreation to both local residents and the community at large.

Proceeds from the Golf Outing benefit ongoing improvements within the Township's Park System. Areas like the Central Park Pavilions, Environmental Education Area, Game Grove, LifeTrail, Sensory Trail, and an expanded trail system, have all been built or improved.
